The Job will include **Procurement of Stereoscopic Sattelite Imagery and Digital Surface Model for Gwadar Smart Port City Master Plan Area** for use in Present and Future Planning Studies.

The Contracting Firm shall be required to provide the following Services under this Procurement:

- **Field Survey to establish Ground Control Points (GCP)**
- **Topographic Survey**
- **Acquisition of Stereo Satellite Imagery**
- **Digital Surface Model (DSM)**
- **Digital Terrain Model (DTM)**
- **Normalized Digital Surface Model (NDSM)**

- **Ortho-Rectified Imagery**

Sealed Bids are invited from Reputable National and International Bidders having sound Geographic Information System (GIS) and Surveying Experience. Competitive Bidding shall be held under the '**Single Stage, Two Envelopes**' procedure as defined in Balochistan Procurement Rules 2014.

3. Bids received after the Due Date/Time while Tender Documents shall be NOT be sold after 11th May 2017
4. Detailed RFP can be obtained from the Office of the Undersigned on any Working Day during Office Hours on Payment of Tender Fee of PKR 2,000/-
